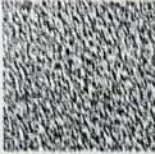


1. DAV college Trust and Management Society, New Delhi/DAV College Managing Committee, New Delhi is a registered Trust/Society under the Societies Registration Act.
