

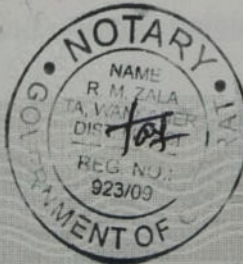

This affidavit is made in good faith and truthfully represents the circumstances surrounding the delay in obtaining the NOC.

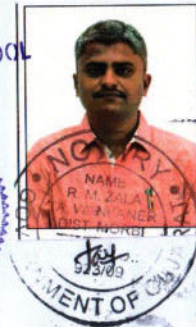
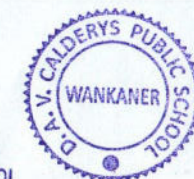

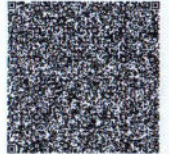
