With reference to the subject cited above, we would like to inform you that, the Japanese Encephalitis (JE) vaccination campaign will start from 27th November, 2017 in 13 districts of Odisha i.e. Balasore, Cuttack, Dhenkanal, Ganjam, Kalahandi, Kendrapada, Khordha, Koraput, Nabarangpur, Puri, Rayagada, Sonapur, Sundergarh. During the campaign, nearly 71.8 Lakh children in the age group of 1 year to 15 years will be vaccinated with one dose of JE vaccine. The campaign activity will continue for 2 – 3 weeks (up to 15-20 days) depending on the beneficiary load and as per the micro plan prepared by the district. After completion of the campaign, JE vaccine will be included in the routine immunization programme.

During the initial campaign period, the vaccination will be done for school going children in their respective schools (both Govt. and private), followed by vaccination at the community level.

In this context, support of the District Education Officers, Block Education Officers, School Principals, Head Masters, teachers of both Government and Private Schools is highly desirable. Hence, you are requested to undertake following activities to achieve 100% coverage during the campaign:-

- I. Enlisting of all students below 15 years (Class wise) and sharing the same with health staff
- II. Conduct parent – teacher meeting, prior to campaign to educate parents
- III. Sensitize students regarding the vaccine & its benefits
- IV. Ensure full attendance on the session day
- V. Assist during session day in the school for vaccination of children

You are, therefore, requested to issue necessary instruction to the District & Block Education Officers to support the health officials at their level for success of the campaign. We are also looking forward for your personal intervention in this crucial campaign activity for achieving 100% coverage.


